1 DISCLOSURE

In the Protection of Personal Data Law No. 6698 (“PPD Law”), personal data holders (hereinafter referred to as “Data Holders) defined as specific persons in relation to the processing of their personal data are given certain rights to the processing of their personal data in the Article 11 of the PPD Law

Pursuant to paragraph 1 of Article 13 of the PPD Law; The applications to be made to our Company as Data Responsible regarding these rights must be communicated to us in writing or by other methods determined by the Personal Data Protection Board (“Board”). Within this framework, the “written applications to be made to our Company” should be sent to our Company by one of the following methods;

- a. Hand by Confirmed Identity,
- b. Via Notary Public,
- c. By Registered Letter With Return Receipt or
- d. Via Registered E-Mail

Information regarding the application channels by which the written applications will be sent to us is provided in the table below.

If other methods are determined by the Personal Data Protection Board, these methods and the way applications will be received through these methods will be announced by our Company.

Your application will be replied, according to the nature of the request, “as soon as possible and within thirty days” at the latest from the date of receipt of your request, in accordance with paragraph 2 of Article 13 of the PPD Law. Our responses will be sent to you in writing or electronically in accordance with the provisions of Article 13 of the relevant PPD Law.

In case of any discrepancy between the original Turkish version and any translated version of this document, the Turkish version must be taken into consideration.
